

Requesting an exempted role:

After having created an EU-Login account, you will need to try to access TRACES at least once for your user account to become active.

Using the link <https://webgate.ec.europa.eu/tracesnt/login> , enter your credentials and you shall be redirected to the following screen where you shall be asked to select your purpose of registration:

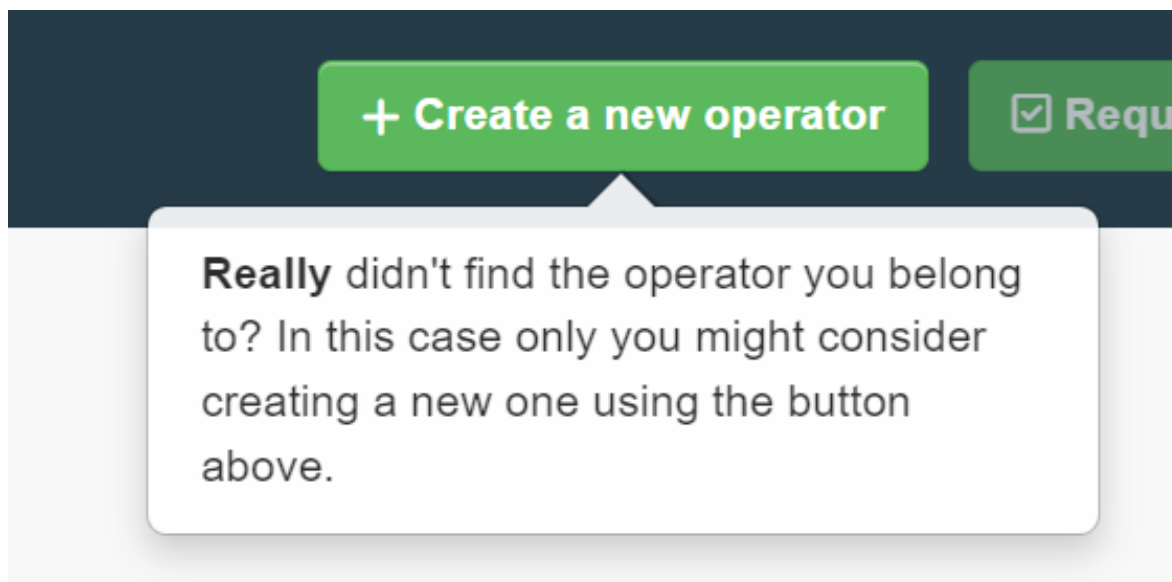

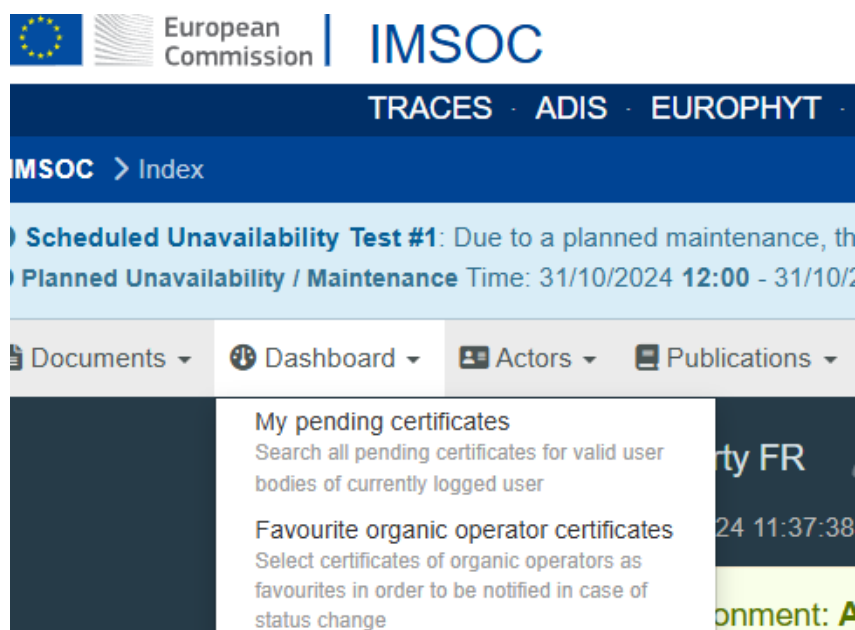
